Mirena Intrauterine Device Financial Policy

The nurse will send in a prescription to Caremark pharmacy for the device. Caremark is the only retailer for this product. Along with the prescription, we will also send in your phone number and insurance information. Caremark will contact your insurance company to verify benefits for Mirena. These benefits will be based on your pharmacy benefits NOT your physician benefits.

If your benefits are payable at 100%, Caremark will automatically ship us the device. We will contact you once it's received to schedule your insertion appointment. The appointment for insertion must be within 5 days of starting your period (day 1 is the first day you bleed).

If this is a covered benefit but not payable at 100%, Caremark will contact you directly to make payment arrangements for any balance you may owe. Once the arrangements are made and/or fulfilled, they will ship us the device. We will contact you once it's received to schedule your insertion appointment. Again, insertions must be within 5 days of starting your period.

If this is NOT a covered benefit, Caremark will contact our office; then we will inform you. You will then need to contact Caremark directly to purchase the device as a private pay service. You will have two payment options which are both interest free.

Once you have fulfilled your requirements with Caremark, they will ship us the device. We will contact you once it's received to schedule your insertion appointment. Remember, insertions must be within 5 days of starting your period.

Private Pay patients

At your appointment, you will owe the insertion fee (\$175).

Insured patients

At your appointment, you will owe your co-pay for the insertion procedure. After the insertion, we will file a claim with your insurance company. If the insertion is a covered benefit and there is a credit on your account, we will refund you accordingly once your insurance has paid on the claim. The refund may or may not be the exact amount of your initial upfront payment depending on the amount your insurance pays and any other debts outstanding on your account. If this is not a covered benefit, you will be responsible for the remaining balance.

Please feel free to contact your insurance carrier to inquire about insertion benefits. Also, keep in mind, our physicians may do a pregnancy test.
